"How can health organisations realise the benefits and take advantage of new technologies such as Artificial Intelligence (AI), whilst at the same time ensure that quality standards and ethical treatment and care are maintained?"

- 1. AI Accelerator! How might we foster innovation in AI in healthcare, whilst reducing risk and avoiding harm.
- 2. Skills 3.0 How might we prepare, educate and support everyone (practitioners, consumers/patients, general public) in the development and adoption of AI in healthcare and deliver better patient outcomes?

Digital Platforms supporting private healthcare - Aged Care case study

"How can we better link hospital discharge to aged care services and residential aged care facilities?

- 1. YourOptions.com digital app to compare and select facilities with a virtual assistant. Using a government subsidised model where data is free of charge. Premium and more targeted support services would involve a cost.
- 2. Al enabled online service concierge service for new residents that provides transparency to potential new resident, their carers and families. A government subsidised model moving to a chargeable model as it matures.
- 3. Our target a hospital enabled solution where discharge nurses know facility and bed availability to reliably refer family to connect. This will a KISS solution focused on better connections between hospitals and aged care facilities.
- 4. My Aged Care enhanced and actually working to support transitions of care.

 This may require a rethink of how government may work with aged care industry and other players to connect the various parts of the system.

Intelligent Procurement

"How can we rethink the supply chain and procurement in healthcare to be smarter, get better return, and achieve efficiencies?

- 1. Predictive analysis in procurement Data analysis with complimentary processes to apply to supply demand.
- Approval governance automation building in streamlined and digital approval processes to high demand regular procurement as a consistent and repeatable process.
- 3. Data Visualisation for predictive demand where supply demand and purchasing requirements are more visible to staff in the business. Getting staff on to be more responsive to purchase and replacement requirements.
- MaterZON building and linking catalogue purchasing direct from business to supplier removing internal procurement middle man in the purchasing chain.
